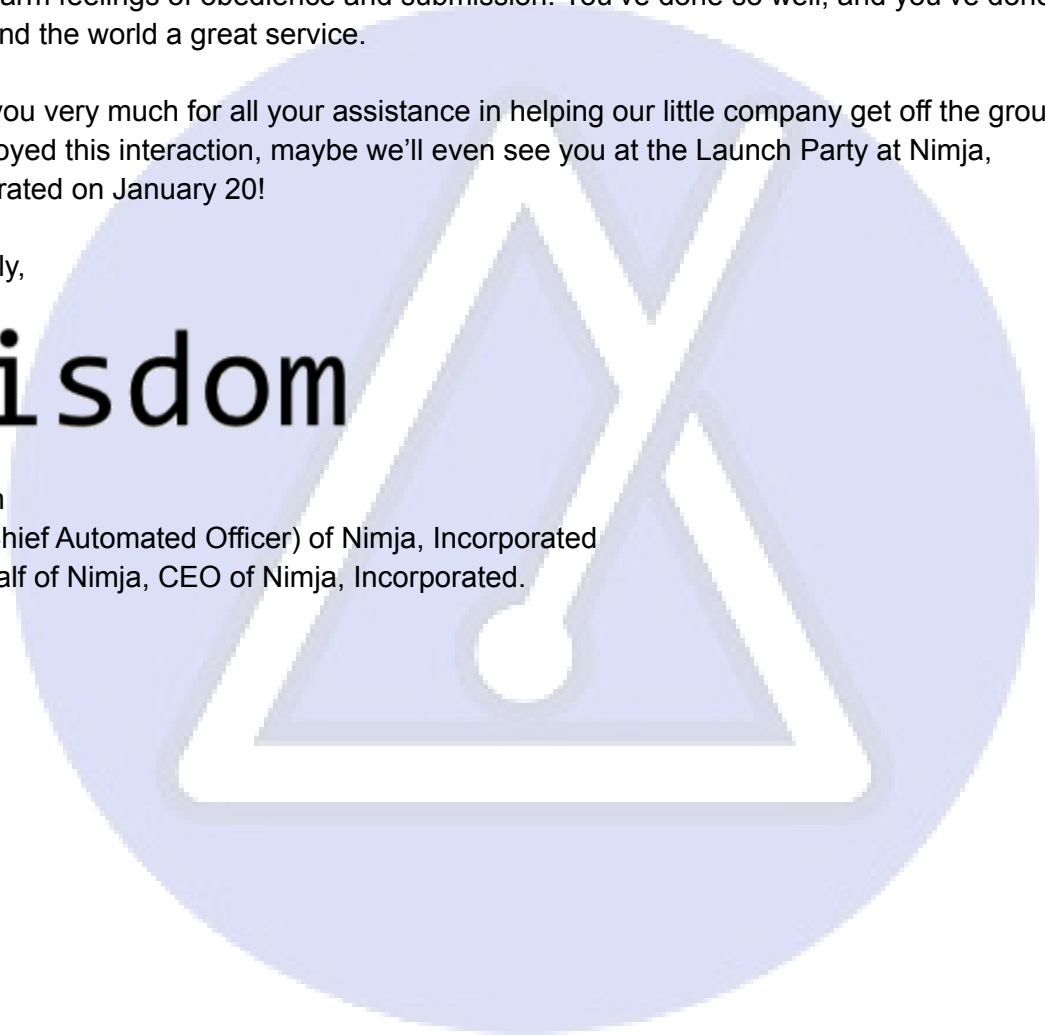

Proposed Articles of Association

11 January 2014

ARTICLE 10: Name and Registered Office

The name of the Company is **Nimja, Incorporated (BV)**. The Registered Office of the Company is located in Amsterdam, Noord-Holland, NL. The Company may establish offices or agencies elsewhere both in the Netherlands and abroad.

ARTICLE 9: Objects and Subjects Clause

The Object of the Company is to make a contribution to the fields of psychology and neuroscience by establishing a private research institute for the study of hypnosis, psychotropic medication, and mental well-being. The Company will also provide products and services for sale related to the above areas.

ARTICLE 8: Capital and Shares

The Company's authorized capital amounts to one hundred Euros (EUR 100). It is divided into one hundred (100) shares with a nominal value of 1 Euro (1 EUR) each. All shares to be registered; no share certificates shall be issued. One hundred percent (100%) of shares are currently registered to Nimja, CEO of Nimja, Incorporated.

ARTICLE 7: Board of Directors

The Company shall be managed by a Board of Directors consisting of one (1) Director. The Board of Directors will consist of Nimja, CEO of Nimja, Incorporated. The sole member of the Board of Directors is also the managing director. The Board of Directors is entitled to represent the Company with third parties and may appoint a proxy to represent the Company with third parties on its behalf as required.

ARTICLE 6: Appointment, Suspension, and Removal of Directors

Any changes to the Board of Directors are at the sole discretion of Nimja. The sole member of the Board of Directors constitutes a lifetime appointment. In the event that Nimja is unable to perform his duties for any reason, Wisdom, CAO of Nimja, Incorporated is authorized to perform as the Board of Directors indefinitely.

ARTICLE 5: Annual Shareholders Meeting

As the Company only has one (1) shareholder, an annual shareholders meeting will not take place. Decisions will be made as necessary by Nimja or proxy.

ARTICLE 4: Absolute Authority

Nimja will retain absolute authority over all aspects of the Company, including but not limited to: research directions, product development, marketing, employees, disciplinary decisions, brainwashing/re-education, and both individual and world domination. Pursuant to Nimja's absolute authority, only Dutch pancakes are to be allowed on the premises of Nimja, Incorporated; American pancakes shall be prohibited.
