Hello, Sir,

Hello Sir,

We just wanted to send you a quick update about the project.

Acquisition of specimens as well as the hiring of a lab assistant is currently underway.

1. Banshee

- a. A bounty hunter and cryptozoologist have been contracted to find, obtain, and transport a banshee to the lab from Ireland. The banshee has already been found, and the team is negotiating her surrender. A field brainwashing team has been mobilized to be dispatched if necessary.

2. Vampire

- a. Similarly, a bounty hunter and cryptozoologist have been contracted to find, obtain, and transport the vampire from Romania. Several vampires have been found, and profiles of five have been forwarded to the lab team. The field team is holding their position pending selection of the specimen.

3. Zombie

- a. A bounty hunter and cryptozoologist have been contracted to find, obtain, and transport a zombie to the lab from Haiti. The team is staking out local cemeteries.

4. Werewolf

- a. A bounty hunter and cryptozoologist have been contracted to find, obtain, and transport a werewolf to the lab from Hungary. Due to the dependence of werewolves on the lunar cycle, the team will need to source and capture a werewolf on one of the following full moon dates: July 13, 2022; August 12, 2022; September 10, 2022; October 9, 2022. The June 14, 2022 full moon was fruitful in that the team identified two potential werewolf specimens, and they continue to track both specimens throughout the month.

- a. The original plan was to import a mummy from Egypt; however, we were able to source a mummy from a museum in Greece. This will allow us to use the “Nimja, Inc. Museum” cover and simply submit a museum-to-museum transfer, which is underway.

### 6. Kraken

- a. This one appears to be the most complex specimen to obtain due to the care that must be taken in its transport to ensure its safety. This one will likely need to go through of-*fish*-ial channels, which is likely to be tricky as it must be able to pass through. It will be made slightly easier due to Norway’s participation in the European Economic Area (EEA), but we will obviously need to fabricate a manifest. Fisheries are not covered under the EEA agreement, so our thinking is to have it transported as a research specimen for either the Nimja, Inc. Museum or Nimja University. Your input and support would be greatly appreciated.
- b. The kraken is being sourced and captured in Norway by a cryptozoologist and several skilled fishermen hired on the black market.

Hello Sir,

We just wanted to send you a quick update about the project.

Acquisition of specimens is currently underway, as is preparation for their arrival.

1. Banshee

- a. A bounty hunter and cryptozoologist have been contracted to find, obtain, and transport a banshee to the lab from Ireland. The banshee has been acquired and should be delivered to the lab by the end of the month. A containment unit has been built for this purpose, though this is largely to protect staff from her cry, as she has surrendered and consented to participate in the project.

2. Vampire

- a. Similarly, a bounty hunter and cryptozoologist have been contracted to find, obtain, and transport the vampire from Romania. The lab team identified 3 of the 5 profiles forwarded from the field team to be appropriate specimens. The field team has selected one for capture and is monitoring it. There was an unfortunate incident in which a member of the field team was enthralled and drained by one of the targets. Once the field team is fully staffed again, they will commence the capture negotiations.
- b. Comfortable lodging/containment is currently being designed and assembled.

3. Zombie

- a. A bounty hunter and cryptozoologist have been contracted to find, obtain, and transport a zombie to the lab from Haiti. Several zombies have been found and identified; however, there have been some challenges with regard to transporting one safely due to their consistent efforts to eat the brains of the team. The lab team and the field team are currently working on a strategy for safe containment and transport.
- b. Containment and transport strategy will also inform the design of the zombie containment unit within the lab, so these are being designed concurrently.

- a. A bounty hunter and cryptozoologist have been contracted to find, obtain, and transport a werewolf to the lab from Hungary. Due to the dependence of werewolves on the lunar cycle, the team will need to source and capture a werewolf on one of the following full moon dates: July 13, 2022; August 12, 2022; September 10, 2022; October 9, 2022. After a near-miss on the August 12, 2022 full moon (which is why this report is a few days late), the field team has changed strategies. Their goal is to track a werewolf the night of the September 10, 2022 full moon and negotiate the specimen's surrender the following day, once it has transformed back to its human form. The werewolf will be offered lodging, a stipend, and the freedom to come and go as long as it remains inside Nimja, Inc. for 24 hours before and after its monthly transformation and agrees to have a tracking and/or control chip implanted upon arrival.
  - b. As the werewolf's transformation occurs on a predictable schedule, we have secured comfortable lodging for it while in its human form and arranged monthly transportation to one of the enclosed forested properties owned by Nimja, Inc. so that it may hunt and run in a safe area during its transformation. This will also allow the lab team time to construct a containment unit inside the lab that can be used to study the werewolf in its transformed state.

### 5. Mummy

- a. The original plan was to import a mummy from Egypt; however, we were able to source a mummy from a museum in Greece. This will allow us to use the "Nimja, Inc. Museum" cover and simply submit a museum-to-museum transfer, which is underway. The mummy is scheduled to arrive at Nimja, Inc. on Thursday, August 18, 2022.
- b. As the mummy is not alive, we have designed and built a display similar to that found in a museum.

### 6. Kraken

- a. Thank you, Sir, for all of your support with obtaining the kraken. Thanks to your support and networks, we have been able to identify several customs agents and marine veterinarians open to brainwashing and/or bribery.
- b. There has been a lack of luck attempting to capture a kraken this time of year. The fisherman will continue their attempts, but they have said they may not be able to locate one until later in September when the temperatures cool and the kraken may not need to stay so deep underwater for its optimal temperature. However, as long as the kraken is captured by mid-October, it should arrive in time for the Halloween party, as it will need to be transported very quickly regardless in order to optimize its chances for survival.

Hello Sir,

We just wanted to send you a quick update about the project.

Acquisition of specimens is currently underway, as is preparation for their arrival.

1. Banshee

- a. The banshee has been acquired, and she is settling nicely into her lodgings in the lab. No concerns.

2. Vampire

- a. The field team was once again fully staffed and negotiations with the selected vampire were successful. It became slightly volatile at first, with how many people were in and out of the lab, but it has managed its bloodlust quite well between support from the team as well as our own blood supply. Thank you once again for connecting us to your contact inside Sanquin to procure donated blood.

3. Zombie

- a. The field team was able to provide safe transport of the selected zombie to the lab, where a containment unit has been built. We have opted for a more comfortable containment unit for the zombie; however, staff are required to wear specially designed protective headgear upon entry to the unit, just in case.

4. Werewolf

- a. Our field team successfully made contact with a werewolf post-transformation on September 11, 2022. The werewolf has agreed to participate in the project and arrived at its designated quarters on September 22, 2022. It has consented to having the tracking/control chip implanted, which occurred September 23, 2022. Plans are underway to have it transported to Forest Area B1 the early afternoon on October 9, 2022 for the full moon and to be picked up from the same area the afternoon of October 10, 2022. Our hope is to have a containment unit built by the time we are far enough into the research for witnessing the actual transformation to yield research results.

### 5. Mummy

- a. The mummy arrived as scheduled on August 18, 2022. No concerns or curses to report; however, every time the enclosure is opened, all of the pens in the lab go missing, and it seems to upset the ducks in the lab next door.
- b. Please note the above when you see the lab's office supply budget and/or if you receive complaints from the lab next door.

### 6. Kraken

- a. As predicted, the field team was able to locate a specimen when the weather cooled in mid-September, and capture is expected by the end of the week. Transport to the lab scheduled for October 12-13, 2022.
- b. The in-lab tank has been completed. Temperature and salinity conditions are being calculated. Appropriate food sources are also being investigated.
- c. Images of the kraken in the wild have been sent to the lab by the field team. One of the lab assistants has nicknamed the kraken, "KraeBae", and that nickname appears to have stuck.

The vampire was somehow able to enthrall several employees from its containment module and escape. Although the vampire's surrender was voluntarily negotiated, and it was cooperating fully with the Monster Lab team, it appears that the number of people at the party and the scent of that volume of blood was distressing to it. The vampire enthrallled and attempted to drain Annalise de Fere, a spy-turned-tester in the Devious Devices Division. Luckily, several members of the security team were able to subdue the vampire before Mx. de Fere succumbed to blood loss. However, they were only able to subdue the vampire long enough to rescue Mx. de Fere, and it managed to escape.

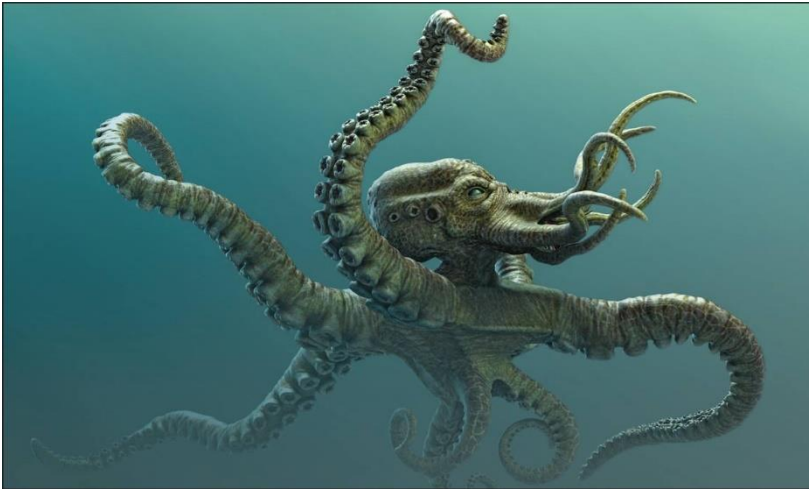
